

TERMS AND CONDITIONS FOR THE MEMPHIS TOURISM & BAZ LUHRMANN'S ELVIS PROMOTION ON CONCRETE PLAYGROUND

Information on how to enter to win tickets to the Australian premiere of Baz Luhrmann's ELVIS form part of these terms and conditions.

By participating, entrants agree to be bound by these terms and conditions.

ELIGIBILITY

- Entry is open to residents in NSW, VIC and QLD, aged 18 years and over.
- Employees and their immediate families of the Promoter and its agencies associated with this Promotion are ineligible to enter.

ENTRY

- The Promotion commences at 9am on Monday, 9 May 2022 and closes at 9am on Friday, 27 May, 2022. No entries will be accepted outside of the Entry Period.
- To enter, readers must submit a competition entry through the Concrete Playground website.
- Entries must be received by the Promoter during the Promotional Period only.
- All entries are deemed to be received at the time of receipt by the Promoter, not the time of transmission by the Entrant. Records of the Promoter and its agencies are final and conclusive as to the time of receipt.
