

TERMS AND CONDITIONS FOR THE TRIPS: HOBART CULINARY INDULGENCE PROMOTION ON CONCRETE PLAYGROUND

ELIGIBILITY

- Vehicle Registration Fee (VRF), Administration Fee, Goods & Services Tax (GST), Premium Location Surcharge (PLS) / Concession Recovery Fee (CRF) and Loss Damage Waiver are all included.
- Kilometre Allowance
