# TERMS AND CONDITIONS FOR THE BASIL HAYDEN EVENT GIVEAWAY ON CONCRETE PLAYGROUND

Information contained in this document details how to enter and win passes for you and 2 x friends aboard The Jackson by completing and submitting the entry form as part of these terms and conditions.

By participating, participants agree to be bound by these terms and conditions.

#### **ELIGIBILITY**

- Entry is open to residents in New South Wales only, aged 25 years and over (refer to Privacy for details on age restrictions).
- Employees and their immediate families of the Promoter and its agencies associated with this Promotion are ineligible to enter.

### **ENTRY**

- The promotion commences at 4pm, Thursday 7 March AEDT and closes at 12pm, Sunday 17 March AEDT (Promotional Period). No entries will be accepted outside of the Promotional Period.
